Roof Deck

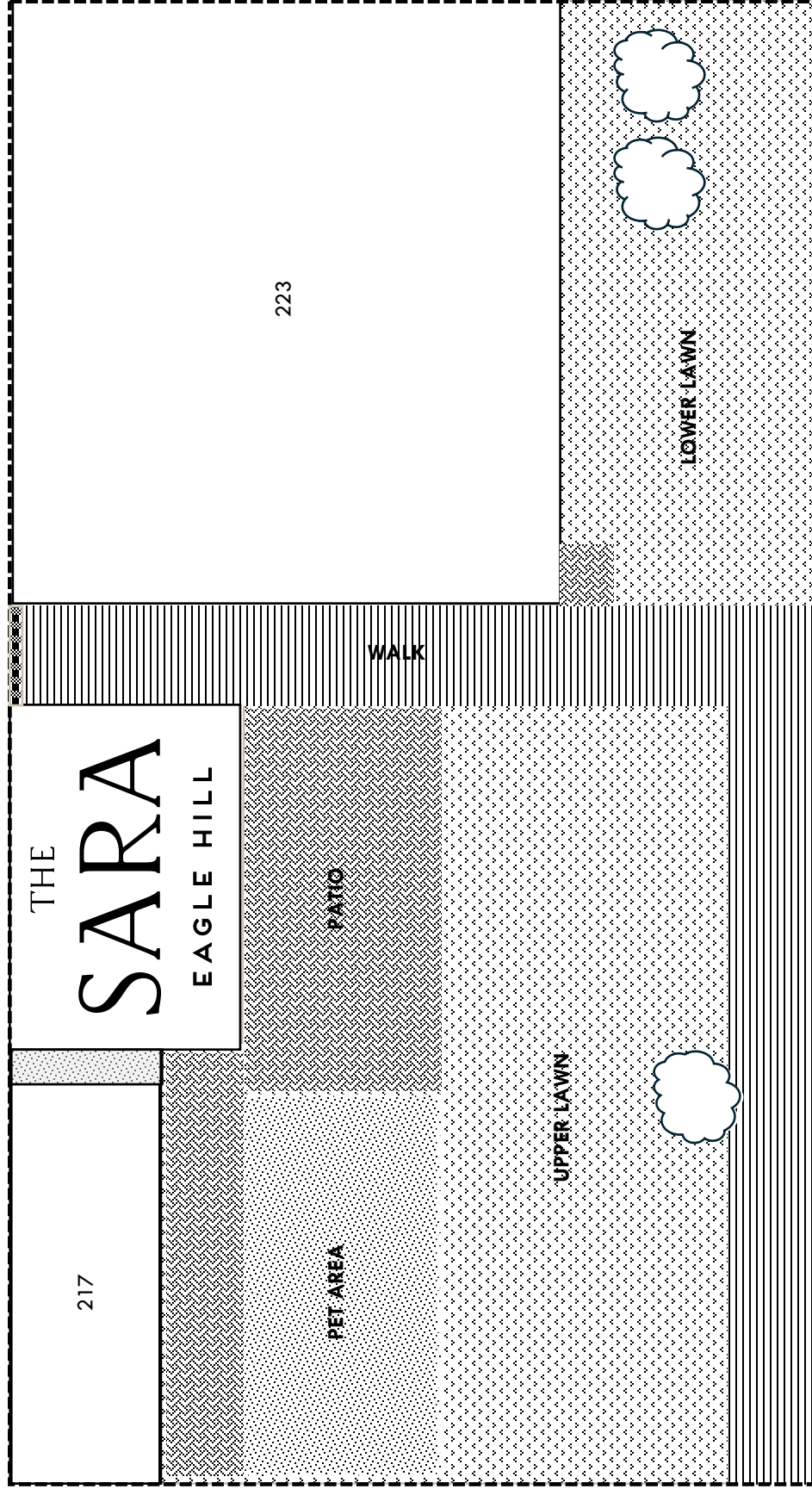
